

A tribute to Trouble—A World Class Border Collie

Beloved Dog of Lynn and Butch Haneke

International Champion CH. Sequoyahpark Eye O' The Storm CD. NA. NAJ. HCT. CGC 02/16/2000 9/27/2012

This beautiful dog had a rough start in life. He was born to a show kennel in Denmark and for the first 3 years lived half the month in a kennel and half in the house. He showed there and obtained his Championship in Denmark before traveling to the US for his AKC show schedule.

In the AKC ring he had the honor of showing UNDEFEATED in his quest for his Championship. Not many of us have had a dog so successful that they always won their class. All of that success came at a high price to his mental health. Living in a show kennel made him so upset that he excessively groomed his forelegs.



He ended up with a granular tumor that needed surgery. Recovery from the surgery also didn't go well in a show kennel where he wasn't in an E-collar and tore his stitches out. Recovery from further surgery wasn't possible at the kennel and his USA co-owner had too many dogs to take him on. That's where I came in. The last week of May 2004 he came to live with me just until the fall of that year.



After Trouble healed physically we worked on the mental aspect of his recovery. In the fall of 2004 he started obedience and agility classes at TKC. He was obviously happier with me even though he occasionally hit the circuit with Greg Strong for a weekend. By the Spring of 2005 we had 6 days of agility shows and both of our Novice titles. That Spring and Summer we also obtained our CD.His USA co-owner knew Trouble would return to self-mutilating if he returned to Denmark so she helped me keep him here.

Trouble spent every minute of the day with either my husband or myself, even going to work with Butch when he worked on an estate near Pickering Creek.

Trouble was the ultimate Border Collie and instinctively knew how to work sheep. He did obtain his American Herding Breed Association Herding title on sheep and ducks. In our first test he was given 10 minutes to finish moving the sheep thru the course. I had it videotaped and later timed our test at just under 3 minutes. Only 2 dogs out of 10 qualified that day. The judge had rolled his eyes when this "barbie doll" BC came in the ring, but he was very impressed when we worked and noted that on our judging sheet.

Cancer took him at 12 ½ but nothing can take the joy he gave to us away.

Cataway Lavender Blue Niki

March 26, 1997 – August 31, 2012

"SHE MADE A DIFFERENCE"





Although she claimed me at $9\frac{1}{2}$ weeks, Niki didn't become mine until she was nine months old. I had no idea what a blessing she would be.

Niki earned many titles in NADAC, AKC, and USDAA agility, but most people remember her as the blue Sheltie in my lap. She earned her CGC and Rally Novice title. But she found her true calling with her TDI Certification. Niki's work with children was sometimes described as a miracle. She worked in three elementary schools helping reluctant first grade readers gain confidence and reading success. At a local nursery school, she spent time with preschoolers helping them get over their fear of dogs. Saturdays often found Niki at a program for young autistic children. There

she was referred to as "our beloved Niki." With Niki, children who didn't talk and didn't interact with other children, came out of their shell. It was overwhelming when one mother said to me, "you'll never know how long I've waited for a child of mine to call me Mommy."

A few years ago, when Niki was being "the dog to talk to " at an animal communication class, the animal communicator said, "She has done more in her 12 years than most adults have done in their lifetime." For three more years Niki continued to work her miracles.

Niki brought me comfort, peace, and unbelievable joy.

"When someone you love becomes a memory, the memory becomes a treasure." I treasure all of the memories.
